The Statewide Interoperability Executive Committee (SIEC) in 2023 continued to address the challenges of statewide interoperability through a transition of leadership. Outgoing Chairperson Tom Andross was presented the "Gavel" for his outstanding leadership while the Incoming Chair Chief George Feole assumed his responsibilities with the same vigor and initiative that he has always presented throughout his law enforcement career. Working Group Chairs also transitioned with Thayer Pronto assuming the Chair for the Operations Group, Rick Todd named Chair of the Radio Frequency Working Group, and Jon Goldman as Chair of the Data Communications Working Group. The Working Group Chairs will be presented with their "official letter of appointment" from Commissioner Quinn at the

This is just one of the many reasons why we, as a rural state, continue to urge the FirstNet Authority to





make a decision regarding future investments to include further infrastructure development. FirstNet connectivity is only as good as the coverage it can provide, for without coverage, it makes no difference in the number of applications offered. The SIEC acknowledges and commends FirstNet/AT&T for the work that has been accomplished in the last five years, what has been achieved is extraordinary, but we also know that there is much more work to be done. We look forward to the challenge in 2024 by embracing this partnership and addressing the continuing needs of our Public Safety community.

In concert with the FirstNet initiative, the SIEC continues to drive and support the Mutualink project which has established New Hampshire as the most connected state in the country. Agnostic in its platform, Mutualink provides unparalleled connectivity across all spectrums anytime and from anywhere. Supported through the New Hampshire Department of Safety, Division of Emergency Services and Communications, Mutualink has grown in value as Public Safety and critical assets around the state understand the value of the platform.

As the year 2023 draws to a close, I would be remiss not to acknowledge all the work that has been directed and accomplished by the SIEC. To each person, I wish to express my heartfelt thanks for all that you have provided in support of this mission. 
